## I. PURPOSE

To define and describe the accepted indications for Oncaspar (pegaspargase) usage in the treatment of cancer, including FDA approved indications, and off-label indications.

New Century is responsible for processing all medication requests from network ordering providers. Medications not authorized by New Century may be deemed as not approvable and therefore not reimbursable.

The use of this drug must be supported by one of the following: FDA approved product labeling, CMS-approved compendia, National Comprehensive Cancer Network (NCCN), American Society of Clinical Oncology (ASCO) clinical guidelines, or peer-reviewed literature that meets the requirements of the CMS Medicare Benefit Policy Manual Chapter 15.

## II. INDICATIONS FOR USE/INCLUSION CRITERIA

### 1. PREFERRED MEDICATION GUIDANCE FOR INITIAL REQUEST:

- a. When health plan Medicaid coverage provisions- including any applicable PDLs (Preferred Drug Lists)- conflict with the coverage provisions in this drug policy, health plan Medicaid coverage provisions take precedence per the **Preferred Drug Guidelines OR**
- b. When health plan Exchange coverage provisions- including any applicable PDLs (Preferred Drug Lists)- conflict with the coverage provisions in this drug policy, health plan Exchange coverage provisions take precedence per the **Preferred Drug Guidelines OR**
- c. For Health Plans that utilize NCH UM Oncology Clinical Policies as the initial clinical criteria, the **Preferred Drug Guidelines shall follow NCH L1 Pathways** when applicable, otherwise shall follow NCH drug policies **AND**
- d. Continuation requests of previously approved non-preferred medication are not subject to this provision **AND**
- e. When available, generic alternatives are preferred over brand name drugs.

### 2. Acute Lymphocytic Leukemia (ALL)

- a. Oncaspar (pegaspargase) use is supported as part of a multi-agent chemotherapy regimen for all sub-types of Acute Lymphocytic Leukemia (ALL), for induction/consolidation therapy, and for therapy of relapsed/refractory disease.

### 3. Non-Hodgkin's Lymphoma

- a. The member has extra-nodal NK/T-cell lymphoma (nasal type) **OR** Adult T-cell Lymphoma/Leukemia **AND**

- b. Oncaspar (pegaspargase) is being used as part of a multi-agent chemotherapy regimen for either first line therapy/induction/consolidation and/or therapy for relapsed /refractory disease.

### **III. EXCLUSION CRITERIA**

1. Oncaspar (pegaspargase) is being used as a single agent and not part of a multi-agent chemotherapy.
2. Dosing exceeds single dose limit of Oncaspar (pegaspargase) 2,500 IU/m<sup>2</sup>.
3. Indications not supported by CMS recognized compendia or acceptable peer reviewed literature may be deemed as not approvable and therefore not reimbursable.
